INCLUDEnyc is the primary source of information for youth with disabilities and their families in New York City. Our mission is to support young people with any type of disability by fostering positive futures, improving their quality of life, and promoting meaningful inclusion for them in the broader community. We believe that all young people, regardless of background or ability, should have access to opportunities, assistance, and services that help them achieve their full potential. Too often, these youth and their families may be disconnected from traditional supports and have difficulty navigating the complex systems of social services intended to address such crucial issues as education, health care, benefits, and employment.

In response, INCLUDEnyc has built critically needed supports—such as multi-lingual direct assistance, workshops and trainings, information resources, service referrals, and personal and public advocacy skill development—that help youth and families improve educational, employment, and independent living outcomes. In 2016 alone, INCLUDEnyc’s services supported close to 9,000 people, and tens of thousands more were reached through online news, videos, and electronic materials. All of our programs are provided free of charge and implemented by a staff that is representative of and sensitive to the needs of our population.

INCLUDEnyc was founded in 1983 by three mothers of children with disabilities who wanted to create a place where parents could access critical information on disability resources and services. Today, INCLUDEnyc remains parent-driven and is one of New York City’s leading resources for families of young people with disabilities.

The following outlines some of our notable 2016 accomplishments:

**Parent and Family Training & Direct Assistance:**

Parents and family members, as well as young adults with disabilities and professionals, can attend workshops and trainings led by INCLUDEnyc's expert staff on a wide variety of disability topics. Individuals may attend in-person workshops held at locations throughout New York City or learn remotely through webinars and live-streams. In 2016, INCLUDEnyc presented 251 workshops and trainings serving 2,072 parents, 960 professionals, and 338 youth. These workshops and trainings were presented in various languages and covered a range of disability topics designed specifically to meet parents' most pressing needs, such as Understanding Your Child's IEP; Advocacy Skills for Parents; Transition and Life After High School; Special Education Mediation; D75 and Alternative Settings for Students with Disabilities; and, The Special Education Advocate. Also in 2016, we piloted INCLUDEnyc Live! a series of live-stream, interactive conversations with experts about parenting and disability.

Our Help Line offers in-depth, one-on-one assistance with English and Spanish-speaking staff year-round. In 2016, our Help Line responded to 3,967 help requests (a 54% increase over the previous year). Through individual phone appointments, Family Educators helped families on a range of disability issues from understanding public education processes and finding after-school programs to navigating social service systems and attaining appropriate supports.

**Youth and Transition Services:**

INCLUDEnyc's Youth and Transition Services are direct service programs for young

people age 14-26. Overall, INCLUDEnyc served more than 1,300 young people in 2016, empowering them with meaningful information, strategies, and self-advocacy skills.

Project Possibility engages young people with disabilities—age 16-26 from under-resourced neighborhoods—and works with them to identify and apply for postsecondary school programs or jobs. Project Possibility provides hands-on, intensive support with navigating complex service systems, exploring options for education and job training, and creating and implementing plans that maximize self-sufficiency and lead to employment, higher education, job training, or other community involvement. In 2016, INCLUDEnyc assisted 95 Project Possibility participants.

High School Launch assists culturally diverse students with an Individualized Education Program (IEP) who are at greatest risk of poor educational outcomes and unemployment. In Launch, students learn to identify their disability, articulate their learning styles, educational needs and interests, and identify the supports and services they need to succeed in school. In 2016, Launch reached more than 200 students, as well as over 60 parents and 80 academic professionals who support them.

**Information and Outreach:**

Increasing parental knowledge of the rights, opportunities, and vital resources available to their child with disabilities is the cornerstone of INCLUDEnyc's outreach efforts. We recognize that parents and professionals need clear, consistent, and vetted information to make the best decisions possible. Last year, tens of thousands of people relied on INCLUDEnyc for disability information.

INCLUDEnyc provides myriad online resources, such as tip and contact sheets, online videos, and web links on a broad range of disability topics including learning and school, parenting and advocacy, friendship and social relations, family support, and working and adult life. Our electronic communications—such as the weekly Navigator and monthly transition-related ACCESS news aggregates—keep more than 21,500 families and professionals (almost 10% more than 2015) informed on the latest disability community news, events, resources, and information. Our social media presence is a key resource for sharing information with our families and partners. INCLUDEnyc also reaches thousands through information distributed on Facebook, YouTube, Twitter, and Instagram.

In 2016, INCLUDEnyc distributed 43,000 print materials to parents, schools, community centers, health providers, libraries, and at outreach events throughout the city, allowing us to reach families who may not have access to the internet or social media.

**Annual Special Events:**

INCLUDEnyc organizes and presents several annual events throughout the city, partnering with various cultural institutions, nonprofit organizations, and government agencies to provide families with the knowledge and information they need to gain independence and achieve inclusion.

Summer Fun & More is the largest resource fair for providers of disability services in New York City. Summer Fun & More was attended by 900 parents and caregivers and featured 89 service providers in 2016, allowing parents and youth to meet face-to-face with representatives from summer camps and year-round recreational

programs in arts, sports, and other activities. Convening world-famous cultural institutions, camps, independent nonprofits, and government organizations made an important statement about inclusion in our city, and demonstrated the growing access for young people with disabilities and their families.

College is Possible are evening events for special education students interested in attending college. As part of this initiative, youth and families learn about the college admissions process and tour campuses during the fall application season. INCLUDEnyc partners with the New York State Education Department, New York City Department of Education, the City University of New York, and ACCES-VR to provide the information students and families need to make a college action plan. In 2016, College is Possible was attended by 113 parents, professionals, and young people.

Citywide Disability Conference is an annual event in which leading experts in the field share their knowledge on a topic of particular interest to our community. In 2016, INCLUDEnyc presented Learning Disabilities: Unlocking the Future, held in partnership with the Brooklyn Public Library and attended by 100 parents and professionals. The event included a keynote speaker on behavioral healthcare, several breakout sessions on topics such as assistive technology, talking to your child's teacher, advocacy skills for parents and youth, and postsecondary options, among others.

**Partnerships:**

INCLUDEnyc has built a strong network of collaborations with more than 250 schools and community-based organizations throughout the city, as well as national and state agencies. These help INCLUDEnyc expand our reach and augment services, allowing us to

provide robust support to the people who need them most. Several of our most notable partnerships in 2016 include:

Parent Centers are designed to work with parents in supporting their child with disabilities. INCLUDEnyc is the New York State-funded Special Education Parent Center for New York City's four largest boroughs, a member of the federal Parent Training and Information Center (PTIC) collaborative for New York City and Long Island, and the lead partner for the Rehabilitative Services Administration PTIC for New York State.

New York City Council Autism Awareness Initiative, allows INCLUDEnyc to provide free support to families who have a young person with autism through our Help Line, family workshops on issues specific to autism, an early childhood awareness intervention project, community resource events, and intensive, direct support for teens and young adults.

New York State PROMISE (Promoting Readiness of Minors in Supplemental Security Income), in collaboration with Cornell University and NYS Office of Mental Health, is a federally-funded research project designed to determine the effects of financial literacy and benefits support on the lives of families with a young person with a disability who receives Supplemental Security Income. In 2016, as a Parent Center provider in New York City, INCLUDEnyc worked with nearly 700 families to provide increased educational, financial, and social independence and stability.

audit committee and a request for comments or questions. If feedback is received, it is considered by the audit committee, finance director and tax preparer who collectively make the final decision before filing the return.
